- HASA Leadership Awards Committee
  - o Johnny and executive board will serve on the committee
- Administrative Vacancies Concerns
  - Concerns around supporting (i.e., coaches, mentors, logistics training) new administrators
  - An idea was proposed that administrators at extremely large schools receive a bonus based on student enrollment
- Messages from HASA members share from HASA website (Christy)
  - Request to expedite communication of minutes on the website, previous minutes must be approved by board at the following meeting before posted to the website
  - O District leaders would like more representation in HASA
  - District deployed support would suggest schools set up rooms before the support arrives and increase communication
- Topics for Superintendent/HR Round Table with Addison on Wednesday
  - Discussion around salary increases, proposing the merging of principal and district leader pay groups to ensure when someone is promoted from principal to district, they do not start at the bottom of the pay scale.
     Requesting tool kits to support boundary restructuring and school closures
  - Concerns around busing communication and lack of supervision at bus ramps.
  - Discussion around disconnection between administrators and collaboration due to dissemination of information from the top
  - HASA would like to be involved in the proposed schools closing and restructuring boundaries
  - o Concern about the lack of training for instructional coaches
  - Concern about the disconnect of communication with principals and district leadership around new initiatives and updates. Often, we find out from the news or word of mouth. Requesting proactive communication from the district

- Proposal for HASA to conduct a salary study and administrative pay in neighboring districts. Johnny will inquire about options and report back at the next HASA meeting.
- o Recommend the superintendent recognize and acknowledge leaders
- School Board members are requiring district personal to work additional hours and take on extra responsibilities with no concern for workload.
